### Registration For Camp Arrowhead 2020

**Registration is ONLINE!**

1. Please login to your Community Pass account through the Natick Recreation and Parks website at <https://register.capturepoint.com/Natick> or a link can be found at [www.natickma.gov/recreation](http://www.natickma.gov/recreation) and register for your desired weeks starting March 2 at 12:00pm. A non-refundable \$50 registration fee will be required at registration. After registration is complete you will receive an email from CampDoc within 24 business hours.
2. Log into your CampDoc account and complete your registration by filling out the profile and uploading your proof of Physical and Immunization Record by Monday, March 23.  
Assistance in uploading documents or completing your CampDoc profile is available at the Cole Center. For other assistance with CampDoc you may find the FAQ's on the Recreation page or you can email [help@campdoc.com](mailto:help@campdoc.com).
3. Registrants must complete their profile and upload their required documentation by March 23 to be included in the lottery. Incomplete profiles will not be considered.  
**RESIDENTS** who **complete** all these steps by March 23 will receive the weeks they request.  
**NON-RESIDENTS** who **complete** all these steps by March 23 will be added into a lottery.
4. Participants will be notified of their week standings by April 2 and will need to be prepared to provide payment during the following week. If an agency is paying there will be separate paperwork to fill out.  
*Registration cannot be completed over the phone or via fax.*

#### Health and Safety

- A Camp nurse will be on site at all times for day camp. A physician is also on call if needed. All staff are fully trained and certified in First Aid and CPR. A Medication Authorization Form must be filled out completely by the parent(s)/guardian(s) prior to attending camp.

#### Transportation for Natick Residents

- Natick Recreation & Parks Department has limited transportation for six Natick individuals at the price of \$50/Session (\$40/Sessions 1). This service is available on a first-come, first-served basis.

Natick Recreation and Parks reserves the right to deem a child not fit for the program at any time.

### Staff and Volunteers

Many of our staff will be returning to Camp Arrowhead this summer. Complimenting our staff are volunteers who provide a 1:1 relationship. Volunteers who are entering Grade 9 and up are needed for our camp season.

Parents/Guardians of campers may ask to verify that staff and volunteers are CORI'd and SORI'd. Health care and discipline policies as well as procedures for filing grievances may be reviewed with members of the Recreation and Parks Staff if requested.
